1	Tender Management	Improvements in the GTE Template 1. Currently only 250 characters is allowed to enter in description. It has been increased to 1000 characters. 2. While creating the GTE template, Select all option is provided for selecting the items required in the template.
2	Tender Management	Enhancement in Tender Work flow Properties for Application Administrator under the Orgn Hierarchy Master. Currently for Open Limited Tender, minimum bidders required to open the tender is taken from the property named, 'Minimum no of Bidders for Opening Tender' for Limited Tender. No this property has been defined for Open Limited tender exclusively.
3	Tender Management	Alert message displayed while adding a Bid Opener in Enlisted Bid Openers selection master page was inappropriate. The message was changed.
4	Tender Management	Earlier validation of GEMARPTS ID using the GEM web service was carried out Send to Publish page. Now a new page has been introduced before 'Send to Publish' page to validate the GEMARPTS ID. If the user opts for exempted from GEMARPTS option to upload document against the selected reason is made available. Option to upload document against the exemption reason is made configurable. i.e Document upload can be made mandatory or non mandatory.
5	Tender Management	In Pre-Tender integration, GSTN details of the participated bidders have been provided in the XML generated from the web service after AOC.
6	Bid Management	Currently MSME registration is only integrated with Udyog Adhaar. Now system is integrated with Udyam Registration. In Bidder login under My Accounts an icon named Udyam is provided for the purpose.
7	BugFixing	Currently in QCBS tenders with Multi Currency Item Rate BOQ, the Cost based rating is calculated without converting the bidder quoted price in foreign currency into INR. This has resulted in erroneous result. The same has been now rectified by converting the quoted

		price to INR before generating the QCBS Comparative chart.
8	BugFixing	System is displaying the Java Security Certificate Error while uploading BoQ file in the bid submission applet. When the user/client machine is having the Java version 8 update 271
9	Internal	Curently for SMS delivery only the SMS account credentials along with the message was necessary. As per the new TRAI regulations two parameters VIZ. Entity ID and Template ID are now appended in the URL string for delivery. The new two parameters are now validated before the SMS gateway before delivery of the SMS gateway.
10	Reports	In Refund Settlement report, postal code field has been added in the details
11	Reports	In Org Statistical report, Provision to display the count of tender published with GEMARPTSID and Non availability of GEMARPTSID is made available.
